## **Customer Experience Survey Sweepstakes**

**Official Rules** 

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THESE SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

## VOID WHERE PROHIBITED BY LAW. AFFIDAVIT OF ELIGIBILITY / RELEASE OF LIABILITY / PRIZE ACCEPTANCE AGREEMENT MAY BE REQUIRED.

- 1. **ELIGIBILITY:** Throughout 2021, Regional Management Corp. (the "Sponsor") will conduct several campaigns via electronic mail messages requesting that the recipients complete a survey and including a sweepstakes component. These Official Rules govern each such sweepstakes which makes reference to these Official Rules. The sweepstakes ("Giveaways") are open only to legal residents of any of the United States (excluding Arizona) or Washington, DC who are eighteen (18) years of age or older at time of entry and who have received from Sponsor an email ("Email") requesting that they complete a survey accessible by a link within such email ("Survey"). Registered account holder is defined as the person assigned to an email address by an Internet access provider, on-line service provider or other organization responsible for assigning email addresses. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. For purposes of this Sweepstakes, an entry is "received" when the servers for the survey administrator record the entry information.

In the event a prize is not available, Sponsor reserves the right, in its sole discretion, to choose and award a substitute a prize of equal or greater value, without notice. - 7. PRIZE DRAWING, WINNER ELIGIBILITY: As to each Giveaway, a random drawing will be conducted from among all eligible entrees received throughout entire Entry Period of such Giveaway. The drawing will be conducted on the first business day of the month following the month in which such Entry Period ended. Potential winner(s) will be notified via telephone, US mail and/or e-mail and are subject to verification of eligibility. If all prize eligibility materials are not completed by a potential winner and returned to Sponsor before the deadline stated with the materials, such potential winner will be disqualified. In such case, the prize will be forfeited and another potential winner will be selected.
